#### APPOINTMENT OF MEMBERS AT LARGE

#### Sandy Beach Lake Regional Park

## PART I: INTRODUCTION

## 1. Authority

(a) Pursuant to subsection 9(3) of The Regional Parks Act, 2013, the Sandy Beach Lake Regional Park Authority, hereby enacts this Appointment of Members At Large Bylaw.

## 2. Title

(a) This Bylaw shall be known as the "Appointment of Members at Large Bylaw" of the Sandy Beach Lake Regional Park.

## 3. Scope

(a) This Appointment of Members at Large Bylaw shall apply to the whole of the Sandy Beach Lake Regional Park.

## 4. Purpose

- (a) The purpose of the Appointment of Members at Large Bylaw shall be:
  - (i) To provide for the appointment of interested individuals to participate as members of Sandy Beach Lake Park as provided under The Regional Parks Act, 2013.

## **PART II: DEFINITIONS**

In this Bylaw, the following words and terms shall have the indicated meaning, unless otherwise indicated elsewhere in the Bylaw:

INTERESTED INDIVIDUALS means any individual, who, in the executive committees' opinion, has the desire and qualifications necessary to contribute time, energy and expertise to the Sandy Beach Lake Regional Park Authority. The individual appointed will be eligible for election the executive committee for a term to be decided by the executive committee.

BYLAW means the Sandy Beach Lake Park Bylaws.

PARK means the area that is designated as Sandy Beach Lake Regional Parks Authority.

PARK AUTHORITY means the people who are, from time to time, appointed for the purpose of carrying out the management and administration of the Sandy Beach Lake Regional Park.

## PART III: BYLAWS

## A. GENERAL

- 1. Members at Large shall be appointed annually by the executive committee by majority vote.
- 2. The Members at Large so appointed shall not exceed 40% of the total number of members and municipal representatives of the Sandy Beach Lake Regional Park Authority.
- 3. The appointed Members at Large are eligible for election to the executive committee. The term of service shall be three years unless the member at large is replacing a member of the executive committee with less than three years remaining in their term.
