



## PARK ENTRY RULES

Effective June 1, 2023 – Until Further Notice

This document is provided to clarify the expectations of the Sandy Beach Regional Park Authority, as it relates to the rules and associated fees that are to be collected for entry to the Park. Following the guidance provided in Sandy Beach Park By-Law 2020-02, access to the park requires fees to be paid, with exceptions for a select number of circumstances. The clarification of these rules will allow for a consistent standard and to control the abuse that has occurred with the previous guidelines.

### **GENERAL PARK ACCESS – INCLUDING RECREATIONAL USE OR VISITATION TO CABIN/HOMES**

- 1) Access to the park for any reason in excess of 30 minutes requires that the party accessing the park pay a fee of either:
  - a. Daily Pass Fee (in effect at the time of the entry, and subject to change with approval of the Sandy Beach Regional Park Authority – example Park Garage Sale, Park Market Days)
  - b. Seasonal Pass Fee
- 2) Those who wish to enter the park for any reason for 30 minutes or less, must pay the Daily Pass Fee, and will be eligible for a refund of that fee, pending a return to the gate with the time stamped day pass within the 30 minutes.
- 3) **Access without charge is provided to:** Emergency Services, Utilities Services (gas, power, sewer, internet), School Buses, Marked Cabs, Tow trucks or vehicle services (example - AMA/CAA), corporately marked vehicles delivering goods (example – propane, building materials, earthen products, bottled water), Government or Municipal Representatives. or vendors conducting work directly for the Sandy Beach Regional Park Authority (as directed by the Park Manager).

### **VENDOR OR CONTRACTOR – NEW CONSTRUCTION**

- 1) Parties with a development permit that has been approved, with paid permit fees in place will be allowed to have the Vendors Workers **associated with the new construction** enter the Park – to work at the site specified on the development permit. A list of vendors (not workers) with phone numbers is required to be submitted subsequent to the approval of the development permit.
- 2) Once the development permit is closed, and the fees associated with the permit are returned by the Park, free access to conduct “post development” (example – landscaping, decks, interior decorating) is no longer valid.

### **VENDOR OR CONTRACTOR – IMPROVEMENTS, REPAIR & MAINTENANCE, PERSONAL SERVICES (work done at site)**

- 1) Generally speaking, parties that are wishing to enter the Park to conduct ANY WORK SERVICES for a lease holder/homeowner (in excess of 30 minutes) will be required to pay to access the Park as per the rules identified as “GENERAL PARK ACCESS”

**PLEASE DO NOT ASK OUR STAFF FOR ANY VARIANCE TO THIS, AND PLEASE DO NOT BE DISRESPECTFUL OR ABUSIVE IN YOUR INTERACTIONS WITH OUR STAFF - YOUR ACCESS TO THE PARK MAY BE DENIED IF WARRANTED!**
